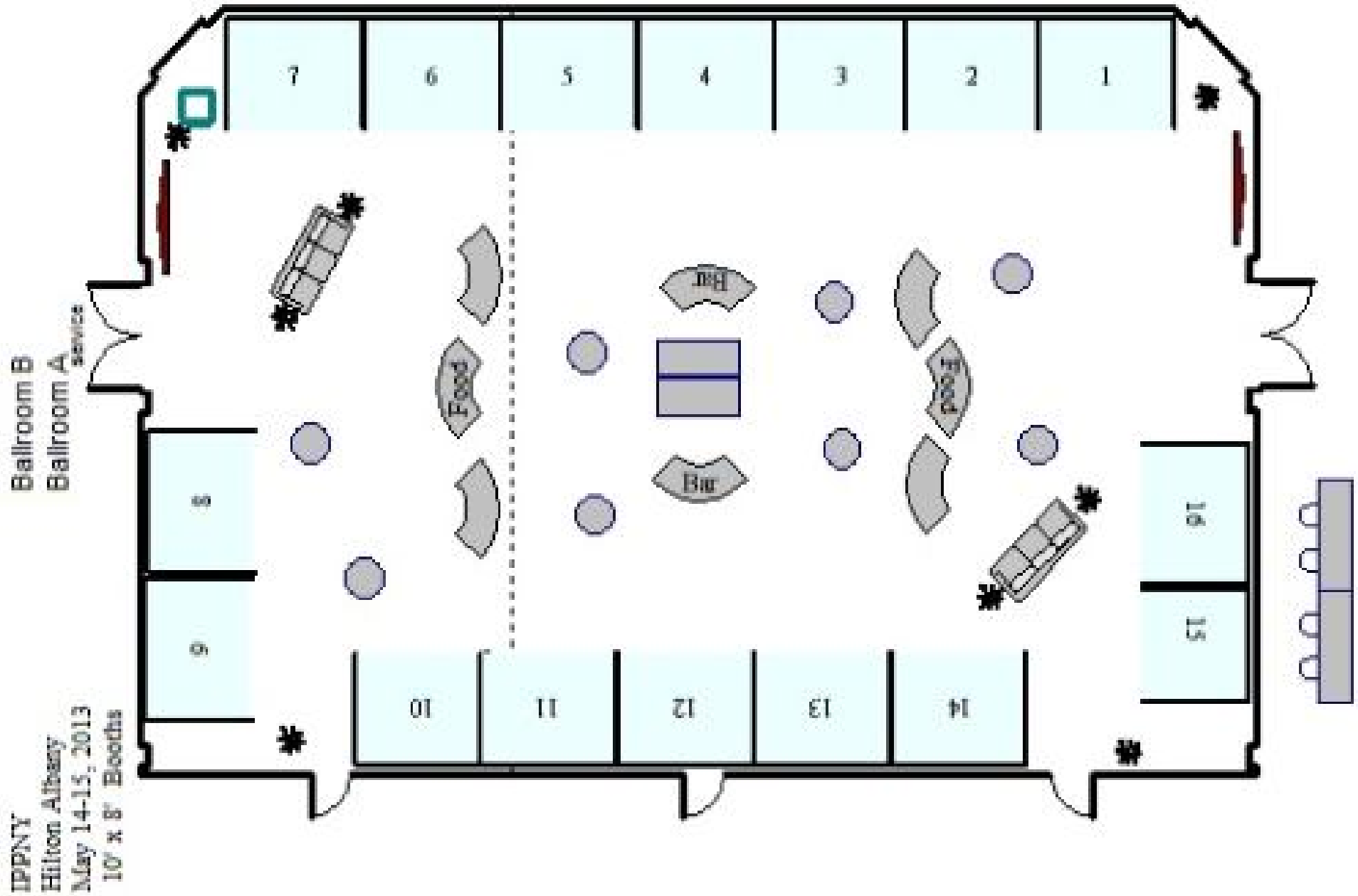
EVENT INFORMATION
