Dues are based upon name plate rating (MW) as listed in the NYISO's Gold Book. Dues are calculated on a calendar year basis (January – December) and are pro-rated for any member joining during the course of the year. Developers

Projects under development pay 50 percent of the final project MW fee.

Power Marketers

All power marketers pay a flat dues rate of \$9,000.

Financial Institutions

Banks, investment houses and other financial institutions pay a flat dues rate of \$6,000.

Suppliers

All other companies engaged in the business of providing goods and services to the wholesale electric industry pay a flat dues rate of \$3,500.
